- **Passing on information for those of you who would want some help with the infants and toddlers in your care, or just some great resources or information. Contact Lisa Isaacson, cell - 785-410-8303, lisa.s.isaacson@ku.edu, Lisa is an Infant-Toddler Specialist with the Infant-Toddler Specialist Network (ITSN) covering the following counties: Geary, Riley, Pottawatomie, Wabaunsee, Lyon, Osage, Shawnee, Jackson, Nemaha, Chase and Morris. I am here to support programs both center-based and home-based that work with infants and toddlers. My support is 100% free and I can also provide KDHE approved training through KCCTO-KITS.**

- **Training** - will be done by the Institute of Child Nutrition April 19 and May 24, from 6pm - 8pm by zoom. We need 25-30 providers per night of training. Once we hit 30 signed up that date will be closed. The March 22 training was great and the presenters did a wonderful job! They kept the class moving and we had lots of participation so thank you to all who were on that call. For those of you who have signed up for April training the packets will be mailed to you soon, so be looking for the booklet to come to you in the mail. **Clarification - When you register with us, that let's me know who to send the pre-registration zoom link to, then when you receive the pre-registration zoom link you need to pre-register so you will then receive a confirmation email and zoom link to JOIN the class from Lisa Rogers, Institute of Child Nutrition.** Every provider is required to get 2 hrs of food program approved training every year.
- The training from the National CACFP sponsors association that is part of the calendar newsletter email that I forward to you isn't KSDE or KDHE approved. It doesn't count.
- The Tier 1 by COVID Waiver does end June 30, 2022, so at the end of June we will mail out information for any other type of tier 1 qualifications, some of you will be going back to tier 2 on July 1, 2022.
- **Family Child Care Food Safety Kit. In April we will do a drawing for the kit. You will earn one ticket by us receiving your Dec, Jan, Feb, and March claims by the 7th of the months they are due. You will earn a ticket if we receive your paperwork on time for all 4 months. You will earn a ticket by having your paperwork up-to-date when Chris calls you for your visit, you will earn a ticket by having no write ups as a result of the home visit. Also, you will earn a ticket for signing up for one of the zoom training sessions by March 15th (deadline has passed). Family Child Care Food Safety Kit consists of the following: One insulated tote for groceries or field trips, one magnet with the cooking temperatures, one food thermometer, two fridge & freezer thermometers, food safety guide, feeding infants booklet, handwashing poster and a pen. April Newsletter will announce who won and then we will work out how to get them to you. We have several of these so look forward to winning one!**
